22 Plaintiff, the Fair Political Practices Commission, a state agency, acting in the name of the People of the
23 State of California, hereby applies for an order to show cause why a preliminary injunction should not
24 be granted pursuant to Government Code section 91003, subdivisions (a) and (b) compelling Defendant,
25 and its agents and employees to file all campaign statements and reports required by the Political
26 Reform Act of 1974 found at Government Code sections 81000 through 91014 in conjunction with all
27 payments made by Defendant between January 1, 2013 and June 30, 2012 to support a proposed ballot
28 initiative to put the City of Sacramento's proposed arena financing plan to a vote in a future city-wide

1 election. This application is made on the grounds that pecuniary compensation would not afford
2 adequate relief, and irreparable injury will result if Defendant is not compelled to file all statements
3 required under the Political Reform Act of 1974 found at Government Code sections 81000 through
4 91014 immediately.

5 Plaintiff has not previously applied for to any judicial officer for similar relief in this matter.
6 This application is based on the complaint, the memorandum on file in this case, and on the declarations
7 on file in this case.
